



Our club goal has been and will continue to be to provide the best possible facility for our members. To accomplish this goal we need all our members to continue their membership for 2012.

Over the years we have offered many categories of membership including introductory offerings. We will be offering both Equity and Non-Equity memberships in 2012. Equity members are those having club ownership, Board eligibility and voting privileges. Non-Equity members do not have Equity rights and have joined under an introductory offering. We currently have 147 golf members of which 105 are Equity and 42 are Non-Equity.

So moving forward with our 2012 membership drive we will be offering both membership categories to our current Non-Equity and to future members. Our goal will be to encourage Equity membership.

The great news is that our current Equity members will enjoy no increase in fees for 2012 with a minor price increase to the unlimited use of a club cart. Our Non-Equity members will have a modest 5% increase rounded to the nearest \$50.

2012 membership offerings will be available August 15 for new members. Those joining on our after August 15 may pay 30% of the 2012 dues and play the remainder of the 2011 season. Full dues payment will be due in April 2012.

In 2011 we added 36 new members. Thank you to all who made referrals to help add these new members. Your referrals are critical to the growth of club membership. I know we all look forward to continuing our membership and seeing our club grow and prosper. Let's grow another 36 members in 2012!
